Welcome to our Privacy Policy. Your privacy is critically important to us.

It is FIBBEE's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to <https://fibbee.store/> (hereinafter, "us", "we", or "<https://fibbee.store/>"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

This Privacy Policy, together with the Terms and conditions posted on our Website, set forth the general rules and policies governing your use of our Website. Depending on your activities when visiting our Website, you may be required to agree to additional terms and conditions.

### **Who are we?**

FIBBEE LLC is an international company with representative offices in Middle East, backed by a development team in Europe (Moscow). A network of distributors provides sales and service support of our products internationally — in Asia, Europe, and North America.

### **What Are Cookies**

As is common practice with almost all professional websites this site uses cookies, which are tiny files that are downloaded to your computer, to improve your experience. This page describes what information they gather, how we use it and why we sometimes need to store these cookies. We will also share how you can prevent these cookies from being stored however this may downgrade or 'break' certain elements of the site functionality. ### **Website Visitors**

Like most website operators, FIBBEE collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each

visitor request. FIBBEE's purpose in collecting non-personally identifying information is to better understand how FIBBEE's visitors use its website. From time to time, FIBBEE may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

FIBBEE may also collect potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving their contact details on <https://fibbee.store/>. FIBBEE only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

## **Scope**

This Global Data Protection Policy applies to your use of this website and to all Personal Information we collect or you disclose during the use of this website. This Policy gives effect to FIBBEE's commitment to protecting your privacy and Personal Information.

## **What information we collect**

When you visit our website, we automatically receive information. This includes information about your IP address, operating system, details about the browser, screen resolution, information collected through cookies and other technologies, the date and time of your visit, and the web page you have visited immediately prior to visiting our website. We collect this information by using a range of different means which include, but are not limited to when you:

- Ask to be included in an email or mailing list;
- Submit your Personal Information to us for any other reason.
- The Personal Information that may be collected includes, but is not limited to:
- Name;
- Contact details, such as email address and/or telephone number;

## **How we use the Information**

FIBBEE may use the Personal Information for business purposes, such as data analysis, developing our website, improving our researches and any of the following purposes:

- Personalize your experience on the website;
- Respond to your inquiries and fulfill your requests;
- Keep you updated with information about our products;
- Provide you with updates and announcements concerning our products;
- Send you marketing materials that you have signed up to;
- Help us better meet your needs;
- We will not use your data for any automated decision-making, including profiling.

In order to provide you with a great experience on this site, we provide the functionality to set your preferences for how this site runs when you use it. In order to remember your preferences we need to set cookies so that this information can be called whenever you interact with a page is affected by your preferences

### **Gathering of Personally-Identifying Information**

Certain visitors to FIBBEE's websites choose to interact with FIBBEE in ways that require FIBBEE to gather personally-identifying information. The amount and type of information that FIBBEE gathers depends on the nature of the interaction.

### **Security**

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

### **Advertisements**

Ads appearing on our website may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by FIBBEE and does not cover the use of cookies by any advertisers.

### **Disclosure of your information**

FIBBEE may be asked or required by law or regulatory authorities to disclose any Personal Information we have concerning you or when necessary or desirable to exercise or preserve our legal rights, or to take action regarding potentially illegal activities. We reserve the right to disclose any Personal Information we have about you if so requested or if we determine it is necessary or desirable to comply with the law or defend our rights or property.

### **Cookies**

To enrich and perfect your online experience, FIBBEE uses "Cookies", similar technologies and services provided by others to display personalized content, appropriate advertising and store your preferences on your computer.

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. FIBBEE uses cookies to help FIBBEE identify and track visitors, their usage of <https://fibbee.store/>, and their website access preferences. FIBBEE visitors who do not wish to have cookies placed on their computers should set their browsers to

refuse cookies before using FIBBEE's websites, with the drawback that certain features of FIBBEE's websites may not function properly without the aid of cookies.

### **Aggregated Statistics**

FIBBEE may collect statistics about the behavior of visitors to its website. FIBBEE may display this information publicly or provide it to others. However, FIBBEE does not disclose your personally-identifying information.

### **Retention terms**

FIBBEE will retain any Personal Information it holds for as long as may be necessary for us to fulfill the purposes outlined within this Policy or in order to comply with any legal or regulatory requirements.

### **Children and Privacy**

FIBBEE takes great care when processing children's data. This website doesn't target and isn't intended to attract children under the age of eighteen (18). FIBBEE doesn't knowingly solicit Personal Information from children under the age of eighteen (18) and doesn't send them requests for Personal Information. If we become aware that we have collected information from a child through this website without needed parents' consent, we will delete that information from our records.

### **Cross-border transfer**

FIBBEE's website may contain links to third-party sites. We don't share Personal Information with those websites and aren't responsible for their privacy practices. Once you have left this website, you should check the Data Protection Policy of the third party website to determine how your data will be handled and how information is collected from you. Your information may be processed in any country where we have official offices, and by using our website you consent to the transfer of information. Transfer of data may take place, provided that the data importer provides sufficient guarantees in respect of the technical and organizational security measures and the processing to be carried out is governed by a contract or legal act binding such data importer.

You will be given a right to access your personal information and correct, amend or delete it where it is inaccurate. We will endeavor to provide your requested personal information within 30 days of receiving your access request. If we cannot fulfill your request, we will provide you with a written explanation of why

we had to deny your access request. To review, correct, update, delete or otherwise limit our use of your Personal Information that has been provided to us, please contact us using the contact information listed below in the 'Contact Us' section and describe clearly your request.

FIBBEE reserves the right to amend this Policy as it finds necessary. We may modify this Policy in order to comply with changes in local laws and regulations. Please ensure that you regularly check this Policy so that you are aware of any changes that are made.
